CUSTOMIZING THE SAMPLE LETTER

CUT TREES FOR DIFFERENT AUDIENCES

For a Landlord or Property Manager

If you are a tenant requesting tree removal from a rental property, your letter should emphasize that you are bringing a safety concern to the landlord's attention. Use a courteous tone and clarify that you are not attempting to take action without permission. The **sample letter of request to cut trees**

above can be revised by changing the opening to: "I am a tenant at [address], and I am respectfully requesting that you consider removing the [species] tree near the back porch because [reason]."

For a Neighbor's Overhang ing Branches

When addressing a neighbor directly, the letter should be diplomatic and collaborative. Instead of demanding removal, suggest a discussion.
