UNDERSTANDING THE IMPORTANCE OF NCOER SENIOR RATER COMMENTS FOR E-5

The Non-Commissioned Officer Evaluation Report (NCOER) is one of the most critical documents in a soldier's career. For a sergeant (E-5), the senior rater comments carry exceptional weight. These comments provide a holistic assessment of performance, potential, leadership, and adherence to Army values. When written

Senior rater comments appear in Part IV of the NCOER form. The senior rater is typically one or two levels above the rater and offers a broader perspective on the rated NCO's performance and potential. For an E-5, the senior rater is often a first sergeant, master sergeant, or company commander. These comments are more than just a summary. They are a forward-looking evaluation that helps senior leaders

assess the NCO's readiness for increased responsibility. The **NCOER senior rater comments for E-5** should clearly articulate the soldier's strengths, areas for improvement, and overall potential relative to peers.

Writing effective senior rater comments requires attention to several components. Each element contributes to a complete picture of the NCO's performance and potential.

CLEAR IDENTIFICATION OF PERFORMANCE LEVELS

The senior rater must rate the NCO in one of five boxes: Most Qualified, Highly Qualified, Qualified, Unqualified, or Not Observed. For an E-5 aiming for promotion, "Most Qualified" is the target. The narrative must align with this box. If you assign

"Most Qualified," the comments must describe a soldier who consistently exceeds standards and demonstrates leadership potential. For "Highly Qualified," comments should reflect solid performance with room for growth. The **NCOER senior rater comments for E-5** must never contradict the box check.

SPECIFIC EXAMPLES OF PERFORMANCE

Vague comments like "Performs well" or "Good leader" do not help the rated soldier or the promotion board. Instead, include concrete examples. For instance:

- "Took charge of a nine-soldier section and achieved 100%

equipment readiness for four consecutive months."

- "Mentored two junior soldiers who advanced to Specialist within 12 months of his guidance."
- "Led a unit physical training program that raised average APFT scores from 245 to 285."

Specific examples make the **NCOER senior rater comments for E-5** credible and impactful. They tell the board exactly what this NCO accomplished.

FOCUS ON LEADERSHIP AND POTENTIAL

For an E-5, leadership is paramount. The senior rater should

comment on how the NCO leads soldiers, manages tasks, and represents the Army. Does this sergeant take initiative? Does he or she solve problems independently? How does the NCO interact with subordinates, peers, and superiors? Comments like "Leads by example" should be backed by evidence. A strong senior rater comment might read: "Demonstrates mature leadership beyond his current grade. Assumes responsibility without being told and consistently places soldier welfare first." This directly addresses the potential for future roles.

HONEST ASSESSMENT OF AREAS FOR

IMPROVEMENT

No soldier is perfect. The best **NCOER senior rater comments for E-5** include professional growth areas framed positively. Instead of writing "Fails to meet deadlines," say "Can improve time management to better balance competing priorities. Showing steady growth in this area." This tells the board that the NCO is self-aware and works on weaknesses. It also reflects a senior rater who provides honest, developmental feedback.

How to Structure

Senior Rater Comments for E-5

A well-structured comment is easier to read and more persuasive. Here is a proven structure for **NCOER senior rater comments for E-5**:

1. **Opening sentence:** State the overall assessment and box check.
Example: "SGT Smith is a Most Qualified NCO who consistently outperforms peers."
2. **Performance highlights:**
Provide 2-3 specific

accomplishments tied to the NCO's duties. Focus on measurable outcomes.

3. **Leadership assessment:** Describe how the NCO leads and develops soldiers. Include examples of mentorship and team building.
4. **Potential statement:** Clearly state potential for promotion and future roles.
Example: "Has the potential to serve effectively as a staff sergeant now and as a platoon sergeant in the future."
5. **Closing recommendation:** End with a strong statement

of support.
Example: "I recommend SGT Smith for immediate promotion and any available broadening opportunities."

Following this structure ensures the **NCOER senior rater comments for E-5** are complete, balanced, and persuasive.

Common Mistakes to Avoid

Even experienced raters can make mistakes. Here are pitfalls to avoid when writing **NCOER senior rater comments for E-5**:

- **Being too generic:**
Comments that could apply to any soldier will not help the board differentiate the NCO. Avoid clichés.
- **Ignoring the box check:** If you rate "Most Qualified" but write comments that sound like "Qualified," the board will notice the mismatch.
- **Focusing only on weaknesses:**
While growth areas are important, the bulk of the comment should highlight strengths and accomplishments.
- **Using passive**

language:

Passive voice weakens impact. Say "Led" instead of "Was responsible for leading." Use active verbs throughout.

- **Exceeding length limits:**
The NCOER form has limited space. Be concise and prioritize the most important information.

Avoiding these mistakes makes **NCOER senior rater comments for E-5** more effective and credible.

Sample NCOER

Senior Rater Comments for E-5

Below are sample comments for different performance levels. Use these as models, but always personalize them for the individual soldier.

SAMPLE FOR A TOP PERFORMER (MOST QUALIFIED)

"SGT Johnson is a Most Qualified NCO who consistently exceeds standards. She led a platoon section through a high-tempo deployment cycle, achieving 100% accountability and a 98% equipment readiness rate. She

mentored four junior NCOs, three of whom were promoted early. SGT Johnson is a self-starter who anticipates requirements and solves problems without guidance. She is the top-performing E-5 in the company and has the potential to serve as a squad leader at the battalion level. I recommend her for immediate promotion and selection for the Basic Leader Course."

SAMPLE FOR A SOLID PERFORMER (HIGHLY QUALIFIED)

"SGT Martinez is a Highly Qualified NCO who demonstrates consistent performance. He manages a team of five soldiers and maintains a 90% qualification rate on gunnery tables.

He has improved his physical fitness by earning a 290 on his most recent APFT. SGT Martinez is reliable and follows instructions well. He can continue developing by seeking additional leadership responsibilities. I recommend him for promotion when fully qualified and encourage him to pursue a Broadening Assignment."

SAMPLE WITH GROWTH FOCUS (QUALIFIED)

"SGT Davis is a Qualified NCO who meets standards but needs to improve in leadership and initiative. He completes assigned tasks but does not yet seek additional responsibilities. I am working with him to

develop his time management and decision-making skills. SGT Davis has the potential to grow into a stronger NCO with focused mentorship. I recommend he focus on professional development and consider enrolling in the Structured Self-Development program."

These examples show how **NCOER senior rater comments for E-5** can vary based on the soldier's performance level and potential.

Tips for Ratees: How to

Prepare for Your NCOER

As an E-5, you can influence your senior rater comments by documenting your achievements throughout the rating period. Here is how:

- **Maintain a brag sheet:** Keep a running list of accomplishments, including dates and measurable results.
- **Seek feedback regularly:** Ask your rater and senior rater for informal feedback before the formal NCOER.
- **Know your job:**

Master your duties and seek additional responsibilities that demonstrate leadership.

- **Build relationships:** Senior raters notice how you interact with others. Be professional and approachable.
- **Request specific comments:** At the end of the rating period, share your brag sheet and ask your senior rater to include specific accomplishments in the comments.

your contributions.
