laid the foundation for its forensic expertise and law enforcement capabilities.

The Shift to Presidential Protection

The late 19th century saw two presidential assassinations that would forever alter the Secret Service's mission. President Abraham Lincoln was assassinated in 1865, just months before the Secret Service was created, but the agency had no role in presidential protection

at that time. President James A. Garfield was shot in 1881 and died months later, yet still no formal protective service existed for presidents. It was not until the assassination of President William McKinley in 1901 that Congress took decisive action.

Following McKinley's murder by anarchist Leon Czolgosz, the public and lawmakers demanded immediate protection for the chief executive. The Secret Service, as the only federal investigative agency, was informally tasked with guarding President Theodore Roosevelt. However, it took several more years for protection to become an official, permanent duty. In 1902, the Secret Service assumed full-time responsibility for

presidential security, marking a transformative moment in its history. From that point forward, protection became a core function alongside financial crime investigation.

EXPANSION OF PROTECTIVE RESPONSIBILITIES

Throughout the 20th century, the protective umbrella of the Secret Service expanded significantly. After the assassination of President John F. Kennedy in 1963, the agency came under intense scrutiny. The Warren Commission made several recommendations, leading to a major overhaul of protective protocols. Congress passed legislation in 1965 authorizing the Secret Service to

protect former presidents and their spouses, as well as vice presidents. Later, protection was extended to major presidential and vice presidential candidates, visiting foreign dignitaries, and their spouses.

By the 1970s and 1980s, the agency's protective responsibilities also included the children of presidents until age 16, and widows of former presidents until they remarried or died. The assassination attempt on President Ronald Reagan in 1981 further underscored the dangers faced by protectees. In response, the Secret Service refined its intelligence gathering, advance security operations, and emergency medical

response capabilities. Today, the agency protects more than 30 individuals and their families, operating with a level of sophistication that includes counter-sniper teams, electronic countermeasures, and cyber threat detection.

The Secret Service Enters the Modern Era:

Department of Homeland Security

A seismic shift in the **History Of The United States Secret Service** occurred after the terrorist attacks of September 11, 2001. In 2003, the Secret Service was transferred from the Treasury Department to the newly created Department of Homeland Security (DHS). This move reflected the agency's growing role in national security beyond financial crimes and presidential protection. The transition allowed

the Secret Service to integrate more fully with other federal agencies focused on counterterrorism, border security, and critical infrastructure protection.

Despite the move to DHS, the Secret Service retained its dual mission. It continued to investigate financial crimes, including counterfeiting, identity theft, computer fraud, and electronic crimes. For instance, the Secret Service's Cyber Fraud Task Forces investigate ransomware attacks, business email compromise, and other emerging cyber threats that target both government entities and private corporations. The agency's expertise in digital forensics and financial analysis makes it a key player in the fight against

transnational organized crime and cybercriminals.

Notable Investigations and Milestones

- **Operation Counterfeit:** In the 1990s, the Secret Service led a major crackdown on counterfeit U.S. currency printed by foreign criminal organizations, seizing millions in fake notes.
- **Enron Investigation:** Secret Service

agents assisted in financial fraud investigations following the collapse of energy giant Enron, helping to unravel complex accounting schemes.

- **Major Cyber Sting:** In 2015, the Secret Service's Electronic Crimes Task Force played a key role in dismantling a global cybercrime ring that had stolen over \$100 million from banks.
- **Protective Foilings:** Numerous assassination plots against presidents and candidates have been thwarted by Secret Service

intelligence and advance work, though many remain classified.
