The applicant must answer with a simple "Yes" or "No." However, truthful and complete answers often require additional explanation, which you can provide in a separate attachment or during the naturalization interview.

Why the N 400 Yes No Questions Matter

These questions are not merely administrative formalities. They are a

legal foundation for the government's assessment of an applicant's eligibility. The **N 400 Yes No Questions** serve several critical functions:

- **Establishing good moral character:** USCIS requires that all naturalization applicants demonstrate good moral character for the statutory period (typically five years for most applicants, three years for spouses of U.S. citizens). QUESTIONS ABOUT CRIMINAL HISTORY

These are among the most frequently asked-about questions. Also: “Have you ever been convicted of a crime?” and “Have you ever been charged with violating any law?” These questions extend to minor traffic violations (except parking tickets) and juvenile offenses.

Important: Even if the record was expunged or sealed, you must still answer “Yes” if you were arrested or convicted. USCIS

expects full disclosure.

QUESTIONS ABOUT IMMIGRATION VIOLATIONS

Another set of critical questions involves your immigration history. For instance: “Have you ever violated any U.S. law or regulation related to immigration?” or “Have you ever been a member of the Communist Party or any other totalitarian party?” These questions help USCIS determine if you have been dishonest in previous applications or have engaged in activities that conflict with U.S. values. If you have ever entered the country illegally, overstayed a visa, or misrepresented yourself to obtain an immigration benefit,

you must answer honestly.

QUESTIONS ABOUT ALLEGIANCE AND MILITARY SERVICE

Questions such as “Are you willing to bear arms on behalf of the United States?” and “Are you willing to perform noncombatant service in the U.S. armed forces?” assess your willingness to defend the country. If you answer “No” to these, you may still be eligible if you can demonstrate a religious or conscientious objection. However, this requires a detailed explanation and supporting evidence.

5. **Do not lie.**

USCIS runs background checks through FBI databases, and many records are

digitized. Lying on the N-400 is perjury under federal law, and it can lead to deportation and a permanent bar from citizenship.

6. **Understand the concept of good moral character.**

Some crimes are bars to naturalization, but not all. If you have a criminal record, you may still be eligible if enough time has passed and you have demonstrated rehabilitation. However, the N 400 Yes No Questions are not the place to omit records; you must disclose them and then argue eligibility.
