- **Dynamic Updates:** As the Corps acquires new equipment, phases out older assets, or reorganizes units, the MCC list is updated regularly. The most current version is maintained by the Marine Corps Systems Command (MCSC) and published through official logistics

portals.

PURPOSE AND USES OF THE USMC MCC CODE LIST

The primary purpose of the MCC Code List is to **enable accurate and fast logistics**. In a combat environment, delays caused by miscommunication can cost lives. A well-maintained code list helps prevent ordering the wrong part, shipping an item to the wrong unit, or misidentifying a critical asset.

Unit Identification and Organization

MCC codes are also used to identify Marine Corps units themselves. These unit-level MCCs are listed in the Marine Corps Total Force System (MCTFS) and are essential for human resources and
