UNDERSTANDING THE VIRGINIA COMMUNICATION AND LITERACY ASSESSMENT (VCLA)

Reading Subtest (091)

The Reading Subtest of the Virginia Communication and Literacy Assessment VCLA consists of 40 multiple-choice questions and has a time limit of 90 minutes. This section measures your ability to comprehend, analyze, and interpret written texts that reflect the kind of reading you will encounter in

Writing Subtest

(092)

To pass the Virginia Communication and Literacy Assessment VCLA, you must achieve a scaled score of 235 on the Reading Subtest and a scaled score of 235 on the Writing Subtest. If you take both subtests in a single session, the total passing scaled score is 470. These passing standards are consistent across all licensure areas, so every candidate must meet the same bar regardless of

the grade level or subject they intend to teach.
