- **Question: "Underline the word that tells what you must do: 'You must write the name of the first President of the United States in the blank space below.'"** (The applicant might underline "write" but the registrar might argue they should have underlined "must" or "do.")

These questions were not tests of literacy; they were tests of obedience and luck. The only reliable "answer" to any question was whatever the registrar
