## Drug Name: Metoprolol (Lopressor, Toprol XL)

- **Contraindications:** Severe bradycardia, heart block (2nd or 3rd degree), decompensated heart failure, cardiogenic shock.
- **Major Interactions:** Verapamil or diltiazem (increased risk of bradycardia and heart block), insulin or oral hypoglycemics (masked hypoglycemia symptoms).
- **Key Counseling Points:** Do not stop abruptly (risk of rebound hypertension). Take at the same time each day. Monitor heart rate and blood pressure regularly. Report unusual weight gain or shortness of breath.
