TRUTH TABLE FOR AND

- True False $\rightarrow$ False
- False True $\rightarrow$ False
- False False $\rightarrow$ False

- True True $\rightarrow$ True

- False True $\rightarrow$ True
- False False $\rightarrow$ False

The OR is true when at least one operand is true. This is the standard "or" used in mathematics and logic.
