YOUR GUIDE TO THE FORM 1290 AUSTRALIAN CITIZENSHIP APPLICATION

The Australian government expects all citizens to be of good character. When you submit the **Form 1290 Australian Citizenship**, you consent to the Department conducting character checks. This includes

reviewing your criminal history, if any. You must declare any convictions or pending charges. In some cases, you may need to provide penal clearance certificates from overseas.

Residency and Intention to Live in Australia

This is a critical section. You must declare any convictions, traffic offenses, or involvement in any court proceedings. Even minor offenses should be disclosed. If you are unsure, it is better to over-disclose than to omit something that could be considered a failure to provide accurate information.

The **Form 1290 Australian Citizenship** requires you to attach specific documents. Typical documents include:

- Certified copies of your birth certificate and passport.
- Evidence of your permanent residency (such as a visa grant letter or your current visa label).
- Two passport-sized

photographs that meet Australian passport standards.

- Character references or penal clearance certificates if living overseas.
- Any documents related to name changes (such as marriage certificates).

Paper Application by Post

If you cannot lodge online, you can print the **Form 1290 Australian Citizenship**, complete it manually, and post it to the Department's processing center. However, paper applications take longer to process. You will need to include certified copies of all documents and a

cheque or money order for the fee.

FEES AND PROCESSING TIMES

The application fee for the **Form 1290**

Australian

Citizenship is

reviewed regularly by the Department. As of 2025, the standard fee is approximately \$540 for most adult applicants, with a reduced fee for applicants aged 16 to 17. Fees are non-refundable, even if your application is unsuccessful, so ensure you meet all criteria before applying.

Processing times for citizenship by conferral vary. The Department aims to process applications within 10 to 14 months for most

applicants. However, complex cases, those with travel history issues, or character concerns may take longer. You can check current processing times on the Department of Home Affairs website.

WHAT HAPPENS AFTER YOU SUBMIT FORM 1290?

Once you have lodged the **Form 1290 Australian Citizenship**, the Department will acknowledge receipt. Here is what typically happens next.

Application

Assessment

The Department will review your application and supporting documents. They may request additional information or ask for further evidence. Respond promptly to any requests to avoid delays.

Citizenship Test or Interview

Most applicants aged 18 to 59 are required to sit the citizenship test. The test covers Australian values, history, and government. You will receive a notification with the date and

location of your test. Study the official resource, Australian Citizenship: Our Common Bond, to prepare.

If you are exempt from the test, you may still need to attend an interview to discuss your application and confirm your identity.

Approval and Ceremony

If your application is approved, you will receive a letter of approval. You must then attend a citizenship ceremony within 12 months of approval, where you will make the Australian Citizenship

Pledge. At the ceremony, you will receive your Australian citizenship certificate. You can then apply for an Australian passport.

COMMON MISTAKES TO AVOID

Filling out the **Form 1290 Australian Citizenship** is straightforward, but some mistakes can cause unnecessary delays.

Inconsistent Travel History

One of the most common errors is providing travel history that does not match Department records.

Double-check your dates and be honest about any absences. If you are unsure about a specific trip, check your passport or ImmiAccount history before submitting.

Incomplete Character Declarations

Failing to declare a traffic ticket or old conviction can be considered a serious omission. Even if you think something is minor, declare it. The Department will verify your criminal history independently, and discrepancies can lead to refusal.

Missing or Incorrect Documents

Ensure all documents are certified correctly if filing a paper application. For online applications, ensure your scanned copies are clear and legible. Missing documents can result in a request for further information, slowing down your processing time.

Can I apply if I have a criminal record?

It depends on the nature of your conviction. You can still apply, but you must declare it. The Department will assess whether you meet the good character requirement. Serious convictions may result in refusal.

No, applicants over 60 are exempt from the citizenship test. However, you still need to submit the **Form 1290 Australian Citizenship** and attend an interview if requested.
