While the form itself is simple—often a single page with blank fields for name, date, block numbers, and signatures—its correct use is mandated by regulations to maintain an unbroken, auditable chain of authorization. The **Dd Form 362 Continuation Page** is not a standalone request form; it must always be attached to the primary form it

supplements. This ensures that all entries, from the start of a leave period to its end (including extensions or cancellations), are recorded in one coherent package.

## Who Uses the DD Form 362?

Any member of the U.S. military service branches—Army, Navy, Air Force, Marine Corps, Space Force, and Coast Guard (when operating under Department of Defense procedures)—may encounter the **Dd Form 362 Continuation Page**. Additionally, civilian

employees of the Department of Defense who use DD Form 31 or similar authorization forms might need a continuation page when their leave or absence requires multiple entries. Commanders, administrative officers, unit personnel clerks, and human resources specialists are also frequent handlers of these forms.

### THE PRIMARY PURPOSE OF THE DD FORM 362 CONTINUATION PAGE

---

Military leave and absence are governed by strict rules, especially concerning chargeable leave balances, emergency leave, transitional leave, and authorized absence for official duties. The main form

(DD Form 31) typically has a limited number of rows or blocks to record dates, locations, contact information, and authorization signatures. When a single leave period extends over many days, or when multiple changes occur (such as early return from leave, extension, or change of destination), the primary form may become cluttered or lack sufficient lines.

Here are the most common scenarios that require a **Dd Form 362 Continuation Page**:

- **Extended leave** – A 30-day leave period may require daily entries for location or reporting instructions.
- **Multiple changes** – A service member amends their leave itinerary several times before departure.
- **Combined absences** – A single request covers both ordinary leave and authorized absence (e.g., permissive temporary duty).
- **Complex documentation** – Additional remarks, endorsements, or contingency plans exceed the space on the main form.
- **Correcting errors** – If a mistake is found on the primary form, the correction may be documented on a continuation

page rather than defacing the original.

# Relationship with Other Forms

While DD Form 31 is the most common partner, the **DD Form 362 Continuation Page** can also be used with DD Form 1271 (Request for Personnel Action), DD Form 1272 (Notification of Personnel Action), and even some specialized leave forms used by individual services. The rule is universal: whenever a Department of Defense form calls for entries that cannot fit in its designated fields, the

## HOW TO COMPLETE THE DD FORM 362 CONTINUATION PAGE CORRECTLY

---

Filling out a **DD Form 362 Continuation Page** is straightforward, but attention to detail is paramount. An incomplete or incorrectly filled continuation page can cause the entire leave packet to be rejected, potentially delaying a service member's travel plans or affecting pay and leave balances.

## Step 1:

# Identify the Primary Service Member Information

## Step 2: Fill in

Before writing anything on the continuation page, note the type, date, and control number of the primary form to which it will be attached. Write the primary form's identification in the appropriately labeled spaces (e.g., "Form Number" or "Document Number"). Many units require you to staple the continuation page to the back of the main form so that the sequence is clear.

At the top of the continuation page, there are fields for the service member's name (last, first, middle initial), Social Security Number or DoD ID Number, rank, and organization. This information must match exactly what appears on the primary form. A discrepancy here can cause the continuation page to be considered a separate, unauthorized document.

## Step 3: Use the Same Block Number Conventions

The continuation page typically has blank rows that correspond to the block numbers or field labels on the main form. For example, if you are continuing Block 12 "Remarks" from a DD Form 31, you should label the continuation section as "Block 12 (Continued)." This makes it obvious to the reviewing authority

which part of the request is being extended.

## Step 4: Provide Sequential Entries

If the main form already has entries for dates, times, and locations, the continuation page should pick up where the main form left off. For instance, if the primary form lists Day 1 through Day 10 of a leave period, the continuation page might start with Day 11. Use the same column headers as the original form to maintain consistency.

## Step 5: Sign and Date

Even though the continuation page is an attachment, it must be signed and dated by the service member and, if required, by the authorizing official. Some units also require the witness or completing official's signature. These signatures confirm that the additional information is authentic and approved. Do not leave signature fields blank.

## Step 6: Attach

## Securely

The **Dd Form 362 Continuation Page** must be physically attached to the primary form. Use a stapler in the upper left corner (or as directed by local procedures). Never use paper clips, as they can detach during handling and cause the continuation information to be lost or mismatched.

### **COMMON MISTAKES TO AVOID**

---

Even experienced personnel can make errors when using a continuation page. Here are the most frequent problems and how to avoid them:

- **Incomplete identification** – Omitting the



primary form's document number makes it impossible to link the continuation page to the correct request.

- **Mixing information** – Writing entries that are out of sequence or that belong to a different block than what is labeled.
- **Using outdated form editions** – The Department of Defense periodically updates the DD Form 362. Always use the most current version available (check online or with your unit's forms manager).
- **Forgetting signatures** – Even a perfect

continuation page is invalid without the required signatures.

- **Handwriting illegibility** – While typed/computer-generated forms are preferred, if handwritten, use black ink and block letters to ensure readability for scanning or filing.
- **Stapling incorrectly** – Attaching the continuation page on top of the main form or behind a different document can cause confusion.

## WHERE TO OBTAIN DD FORM 362

---

The **Dd Form 362**

**Continuation Page** is widely available through official military forms distribution channels. Here are the most reliable sources:

1. **Unit supply or administrative offices** – Most units maintain a physical stock of blank forms for common use.
2. **Official DoD forms websites** – The standard repository is the [Executive Services Directorate Forms Page](#) (formerly known as the DoD Forms Management Program). Search for “DD Form 362” to download a fillable PDF.
3. **Service-specific portals** – Army

eForms, Navy Forms Online, Air Force Publishing, Marine Corps Forms, etc., all carry the DD Form 362.

4. **Commercial printing** – Some stationary supply companies that cater to military installations may carry pre-printed versions, but ensure they are current and authorized for use.

Always verify the form’s issuance date (found in the lower left corner) against the latest version. An outdated form may be rejected during processing.

Inaccurate or incomplete continuation pages can lead to leave being denied, pay adjustments being delayed, or even disciplinary issues if the absence is later questioned during an audit. Military personnel are expected to maintain meticulous records, and the continuation page is a key component of that responsibility.

Moreover, in the event of a legal inquiry—such as a line of duty determination or a criminal investigation into unauthorized absence—every piece

of paper in a service member's personnel file becomes evidence. A correctly prepared continuation page helps demonstrate that the absence was properly authorized and documented at every step.

## Digital Alternatives and Trends

The Department of Defense is moving toward fully electronic personnel records systems, such as the Defense Leave and Pass System (DLAPS) and the Integrated Personnel and Pay System - Army (IPPS-A). In these digital environments, the **Dd**
