SYNONYMS VS. ANTONYMS: CLARIFYING THE CONFUSION

Many learners confuse the antonyms of "behalf" with its synonyms. Common synonyms for "behalf" include **advantage, benefit, interest, welfare, support**. behalf requires authorization. Acting without it is not acting on behalf at all.
