ADDRESS FORM FOR BUSINESS?

WHEN SHOULD YOU USE THE IRS CHANGE OF ADDRESS FORM FOR BUSINESS?

Not every address change requires filing Form 8822-B. Understanding when this form is necessary will save you time and prevent unnecessary submissions. Here are the most common scenarios where you must use the **IRS Change of Address Form for Business**:

1. **You moved your business to a new physical location.** If your office, store, or operational headquarters has a new street address, you need to update your business location with the IRS.
2. **You changed your mailing address.** Even if your physical

location remains the same, if you use a different post office box or have a new mailing address for correspondence, you must file this form.

3. **You changed your business name and address simultaneously.** If both your business name and address have changed, you may need to file both a name change and an address change. The form allows you to indicate both updates.

There are also cases where you do not need to file this form. For example, if you simply update your address on your next tax return, the IRS will process that change automatically. However, if you want to ensure the change is reflected immediately, filing Form 8822-B separately is the recommended approach.

HOW TO FILL OUT THE IRS CHANGE OF ADDRESS FORM FOR BUSINESS

Completing the **IRS Change of Address Form for Business** is straightforward, but attention to detail is crucial. Let us walk through each part of the form.

Part I: Change of Address

In this section, you will provide your business name and EIN. You will also

enter your old mailing address exactly as it appears on your last filed tax return. If your physical location has changed, you will indicate that in a separate line. Part II: Change of Responsible Party

Part III: Signature

The form must be signed by an authorized individual. For a corporation, this is typically an officer; for a partnership, a partner; for an LLC, a member or manager; and for a sole proprietorship, the owner. The signature certifies that the information provided is true and correct.

Part IV: Optional – Third Party Designee

If you wish to authorize another person to discuss your address change with the IRS, you can complete this section. This

is useful if your accountant or tax professional will be handling the correspondence.

HOW TO SUBMIT THE IRS CHANGE OF ADDRESS FORM FOR BUSINESS

Once you have completed the form, you have two primary submission methods: mail or fax. The IRS does not currently accept business address changes online, so you must use one of these traditional methods. Here are the details for each option.

Mailing the Form

The address to which you mail Form 8822-B depends on your business location. The IRS provides specific addresses for different states and territories. You can find the correct mailing address in the form instructions, which are available on the IRS website. Be sure to use a traceable mailing method, such as certified mail, so you have proof of submission.

Faxing the Form

If you prefer a faster method, you can fax the completed form to the IRS at the appropriate fax number. Again, the specific fax number will depend on your business location. The form instructions include a list of fax numbers for each state. Faxing is generally quicker than mailing, but you will not receive a confirmation unless you use a fax service that provides a transmission report. Keep that report for your records.

WHAT HAPPENS AFTER YOU SUBMIT THE FORM?

After the IRS receives your **IRS Change**

of Address Form for Business, they will update their records within four to six weeks, though processing times can vary. You will not automatically receive a confirmation letter unless you specifically request one. To confirm that your address has been updated, you can contact the IRS business line or check your next tax notice or refund check for the new address.

It is also a good idea to follow up with the IRS if you have not seen any indication of the change after eight weeks. You can call the business tax line or visit a local IRS Taxpayer Assistance Center for help.

COMMON MISTAKES TO AVOID WHEN FILING THE IRS CHANGE OF ADDRESS FORM FOR BUSINESS

- **Mailing to the wrong address.** Using an incorrect mailing address will delay processing. Always verify the correct address from the form instructions.
- **Not updating your address with other agencies.** The IRS is not the only entity that needs your new address. You should also notify the Social Security Administration (SSA), your state tax agency, and any other relevant authorities.

RELATED FORMS AND PROCESSES YOU SHOULD KNOW ABOUT

While the **IRS Change of Address Form for Business** is essential, it is not the only form you may need when your business undergoes changes. Here are some related forms and processes to consider.

Form 8822 – Change of Address for Individuals

If you are a sole proprietor, you might be tempted to use this form for your business address. However, sole proprietors should use Form 8822-B for business address changes and Form 8822 for personal address changes. It is important to keep these separate.

Form SS-4 – Application for Employer Identification Number

If you have changed your business address and need to update your EIN application, you can use Form SS-4 to notify the IRS of the new address. However, for an existing EIN, Form 8822-B is the correct form.

Updating Your Address with the SSA

If you have employees, you will also need to update your address with the Social Security Administration. This is done through your quarterly or annual wage reports. The IRS and SSA share information, but it is wise to ensure both agencies have your current address.

State Tax Agency Notifications

Most states require businesses to update their address with the state tax agency separately. The **IRS Change of Address Form for Business** only updates your federal tax records. Check

with your state department of revenue for the correct process.

CONSEQUENCES OF NOT UPDATING YOUR BUSINESS ADDRESS

Failing to file the **IRS Change of Address Form for Business** can lead to several negative outcomes. Some of these are minor inconveniences, while others can have serious financial and legal repercussions.
