3. **End-of-Life**

Recycling:

Equipment that has no resale value and will be dismantled for materials.

Wiping:

For devices that will be resold, using certified wiping software.

• **Degaussing:**

Using a powerful magnetic field to destroy data on hard drives.

• **Physical**

Shredding:

Crushing or shredding hard drives into small pieces.

Data Destruction Dismantling and Material Separation

For any equipment containing storage devices, data destruction is the first priority. Methods include:

• **Software**

Workers manually disassemble computers into component

materials. Common material streams include:

- **Ferrous and Non-Ferrous Metals:** Steel cases, aluminum frames, copper wiring, and gold-plated contacts.
- **Plastics:** Cases and internal components that can be processed into plastic pellets.
- **Circuit Boards:** Sold to specialized refiners who extract precious metals.
- **Batteries:** Sent

to specialized battery recyclers.

- **Hazardous Materials:** CRTs, mercury bulbs, and other toxic components are handled according to regulations.
