Sample Question:

Answer:

The Deed of Trust (in many states) or the Mortgage (in other states) requires notarization. This document is recorded in the county land records and creates a security interest in the property. If the borrower fails to repay the loan, the lender can foreclose on the property. Because this document transfers an interest in real property, it must be notarized to be recorded. The borrower (trustor) is the one who signs and must be notarized.

Sample Question:

What is the Closing Disclosure, and what is its purpose?

Answer:

The Closing Disclosure (CD) is a five-page document that summarizes the final terms of the loan, including the loan amount, interest rate, monthly payment, closing costs, and other fees. The borrower must receive this document at least three business days before closing. The Notary Signing Agent should guide the borrower through the CD, page by page, to confirm that the terms match what was expected. The CD does **not** require notarization, but it is the most important document for the borrower to review carefully.

3. The Signing Ceremony Procedure

This section tests your ability to manage the signing appointment professionally and efficiently. It covers everything from setting up the table to handling signatures and initials.

Sample Question:

Where should the borrower initial on a loan document, and why is this important?

Answer:

The borrower should initial in the specific areas indicated, often at the bottom of each page or next to certain disclosures. 4. Fraud Prevention and Ethical

You should then report your concerns to the hiring signing service or title company. Your integrity is more important than completing a signing.

5. The Loan Process and Role of the Signing Agent

What is the difference between a Refinance and a Purchase transaction?

In a refinance, the borrower already owns the property and is simply replacing their existing loan with a new one. The borrower meets with the Notary Signing Agent to sign the new loan documents.

In a purchase transaction, the borrower is buying the property from a seller. This involves a more complex document package, including the deed from the seller to the buyer. In a purchase, all parties (buyer and seller) may need to sign documents, and the notarization requirements are different. What should you do with the signed document package after the signing is complete?
