This license covers any single vehicle with a GVWR of 26,001 pounds or more, as well as any such vehicle

towing a trailer with a GVWR not exceeding 10,000 pounds. Straight trucks, large buses, and dump trucks typically fall under this class.

- **Class C CDL:**

This license is for vehicles designed to transport 16 or more passengers (including the driver) or for vehicles that transport hazardous materials requiring placarding. The vehicle itself must have a GVWR of less than 26,001 pounds.

Key CDL Endorsements and Restrictions

Vehicles), H (Hazardous Materials), and S (School Bus). Each endorsement requires passing a separate knowledge test, and some, like the H endorsement, also require a background check and a separate skills test. Restrictions, such as the "K" restriction (intrastate only) or "L" restriction (no air brakes), limit your driving privileges based on the vehicle you use for testing.

THE THREE STAGES OF CDL TESTING IN MISSISSIPPI

To obtain your CDL in Mississippi, you must successfully complete three distinct stages of testing. Understanding the format and content of each stage is essential for effective preparation. Your study

Stage 1: The General Knowledge Written Test

Check your tires for proper inflation and tread depth, look for any leaks under the vehicle, ensure all lights and reflectors are clean and functional, and verify that your coupling system (if applicable) is secure. A casual glance around the truck is not sufficient.

Test Anxiety and Rushing

Nerves can cause even the most prepared driver to make mistakes. Take a deep breath before the test begins. Listen carefully to the examiner's instructions and ask for clarification if you do

not understand something. Do not rush through the maneuvers. It is better to proceed slowly and deliberately than to make a hasty error. The examiner is looking for safe, controlled operation, not speed.
