UNDERSTANDING THE SAMPLE EARLY TERMINATION CLAUSE OF RESIDENTIAL LEASE

Example Clause:

Upon providing such notice, Tenant shall pay an early termination fee equal to two (2) months' current Rent. This fee is due at the time the notice is given. Landlord agrees to use reasonable efforts to re-rent the Premises as soon as possible. If the Premises is re-rented before the end of the sixty-day notice period, Tenant's obligation to pay Rent shall cease on the date the new tenancy begins. No early termination fee shall be charged if Tenant terminates due

to a job relocation of more than fifty (50) miles, provided Tenant submits written verification from the employer. This clause does not relieve Tenant of the obligation to pay for any damages beyond normal wear and tear."

This sample early termination clause of residential lease illustrates a balanced approach. The tenant pays a penalty but is not stuck with indefinite liability. The landlord gets a fee and a notice period while being motivated to find a new occupant quickly.

HOW TO NEGOTIATE AN EARLY TERMINATION CLAUSE BEFORE

The best time to address early termination is before you sign the lease. Tenants often feel pressured to accept the lease as written, but many clauses are negotiable, especially in a market with plenty of rental inventory.
