meat, green for produce, white for dairy, and yellow for poultry. Never use the same utensil for raw and cooked food without washing, rinsing, and sanitizing it first.

Cross-contamination occurs when harmful bacteria are transferred from one surface or food to another. The study guide teaches you to always store raw meat, poultry, and seafood on the bottom shelves of the refrigerator, below ready-to-eat food. This prevents drips from contaminating items that will not be cooked further. You should also use color-coded cutting boards: red for raw

The nine major food allergens recognized by the FDA are milk, eggs, fish, crustacean shellfish, tree nuts, peanuts, wheat, soybeans, and sesame. The **Maricopa County Food Handlers Study Guide** stresses that you must prevent cross-contact by using separate equipment and utensils for allergen-free orders. Even a tiny trace of an allergen can trigger a severe, life-threatening

reaction in a sensitive individual. You should always communicate clearly with guests about ingredients and never guess if a dish is safe.
