Storytelling

Make It Interactive

To maximize the benefits of **reading The Cat in the Hat**, engage your child actively. Use different voices for the cat (boisterous and confident), the fish (worried and squeaky), and the children (shy and hesitant). Point to the pictures and ask questions: "What do

you think will happen next?" or "Why is the fish so upset?" This dialogue builds comprehension and prediction skills.

Emphasize Rhythm and Repetition

Revolution in Publishing
