Unlike the softer, more rounded lugs of later models, the "Martin P" lugs are often described as "sharper" or "more sculpted." They have a distinct, angular profile that catches light beautifully. The case is usually in stainless steel, with some rare examples being gold-filled or solid gold. The bezel is often smooth and polished, contributing to the watch's dressy appearance. The caseback is typically solid and may feature the iconic Seamaster hippocampus engraving, though variations exist.

The Dial: Patina and Detail

The Crystal

Most early **Martin P 6m Seamaster** models feature a domed, acrylic crystal. Acrylic was the standard of the era, chosen for its shatter resistance and ease of polishing. A domed crystal adds a beautiful vintage aesthetic, creating a slight distortion that enhances the play of light across the dial. It is a tactile and visual pleasure, a characteristic that modern sapphire crystals often lack.

THE HEART OF THE WATCH: THE CALIBER

Inside the **Martin P 6m Seamaster** beats a mechanical marvel from the golden age of watchmaking. The most common movement found in these watches is the Omega Caliber 500 series (such as the 500, 501, or 502) or the later Caliber 550 series (like the 550, 552, or 560). Rarity and Market Value

The **Martin P 6m Seamaster** is not a common watch. It represents a specific, limited production window from Omega's history. The rarity comes from the fact that many early Seamasters were worn daily, lost, damaged, or simply not cared for. Finding one that has survived in good condition, with its original dial and movement, is a challenge. Their value has appreciated significantly in recent years. Prices for a decent example can range from several thousand dollars for a watch in fair condition to well over ten thousand dollars for a pristine, all-original piece with a beautiful patina.
