## INTRODUCTION

- **Licensing and Professional Registration:** Professionals such as nurses, teachers, and real estate agents may need a police check to maintain or obtain a license.
- **Rental Applications:** Some landlords and property

management companies request a background check to screen tenants.

Knowing why you need a police check will help you determine the correct type of check and the level of detail required.

## Types of Police Checks

Not all police checks are the same. Depending on the purpose and jurisdiction, you may encounter:

- **Basic Police Check:** Shows only unspent convictions (if applicable) or all convictions depending on local legislation. Common for general employment.
- **Standard Police Check:** Includes spent and unspent convictions, plus pending charges. Often used for positions of trust.
- **Enhanced Police Check:** The most detailed, including all police records, cautions, warnings, and sometimes non-conviction information. Used for work with vulnerable populations.
- **National Police Check:** Covers criminal records across the entire country, as opposed to a local check.
- **International Police Check:** Issued by Interpol or via a foreign country's authority for those with cross-border history.

Make sure you confirm with the requesting organization exactly which type of police check they require to avoid submitting an incorrect document.

### **STEP-BY-STEP GUIDE: HOW TO OBTAIN A POLICE CHECK**

The process for obtaining a police check varies by country, state, and the method you choose. However, the general steps remain quite similar. Below, we break down the most common paths, including online, in-person, and through third-party agencies.

## Online

# Application – The Fastest Method

In many regions, applying for a police check online has become the preferred method due to its speed and convenience. Here is a typical workflow:

1. **Visit the Official Website:** Start at the government portal or the official police check service for your jurisdiction. For example, in Australia, you would use the Australian Federal Police (AFP) online portal; in the UK, the Disclosure and Barring Service (DBS) website; in Canada, the RCMP e-services for vulnerable

sector checks.

2. **Choose the Correct Application**

**Type:** Select the appropriate check based on your need (e.g., employment, volunteer, immigration). Some portals will ask for a purpose code or reference number from the requesting organization.

3. **Create an Account or Log In:**

You will likely need an email address and to set up a secure profile.

4. **Provide Personal Information:**

Fill in your full name (including any aliases), date of birth, current and previous addresses for a specified period (usually 5–10 years), and sometimes your Social Insurance Number (SIN) or equivalent.

5. **Upload Identification**

**Documents:** You will need to upload scanned copies or photos of valid ID (e.g., passport, driver's license, birth certificate). The system may guide you through a digital ID verification process.

6. **Consent and Declaration:** Read and accept the terms, and digitally sign the consent form authorizing the check.

7. **Pay the Fee:** Use a credit/debit card or online payment method to pay the non-refundable application fee. Fees vary widely (e.g., \$10–\$100+ depending on complexity).

8. **Submit and Receive**

**Confirmation:** After submission, you will receive a reference

number. Processing can take from a few minutes (if automated) to several weeks (for manual checks). Your certificate may be emailed or mailed to you, or sent directly to the third party.

**Tip:** Ensure your digital ID photos are clear, in color, and meet the file format and size requirements specified by the portal.

## In-Person Application –

## When You Prefer a Physical Visit

If you are not comfortable online or need to provide fingerprints, you may apply in person at a local police station, service center, or designated government office. Follow these steps:

1. **Locate a Convenient Office:**

Visit the police department's website or call ahead to find a location that offers police check services. Some stations have specific hours for fingerprinting.

2. **Bring Original Identification**

**Documents:** Typically you need at least one primary ID (e.g.,

passport) and one secondary ID (e.g., utility bill). Make copies as well, as many offices will keep copies for their records.

3. **Complete the Paper Application Form:** You can often download and fill it out before arriving, or request one at the counter.
4. **Provide Fingerprints (If Required):** For some enhanced checks or certain employment sectors, inked or digital fingerprints are mandatory. The officer will guide you through the process.
5. **Pay the Fee:** Most stations accept cash, debit, or credit cards. Some require exact change.
6. **Wait for Processing:** In-person

applications are often processed on the spot for simple checks, but fingerprint-based checks may take 2–10 business days.

7. **Collect or Receive by Mail:** You may receive your certificate immediately, or it will be mailed to your home address within a few weeks.

**Tip:** Make an appointment if possible to avoid long queues.

## Using Accredited Third-Party

# Agencies

Many jurisdictions allow private companies authorized by the government to process police checks on behalf of individuals. These agencies can be helpful if you need a check for a specific purpose or if the official system is overwhelmed. Here's how it works:

1. **Select a Reputable Agency:**

Look for agencies accredited by the national police or government body (e.g., in the US, the FBI has approved channelers). Check reviews and ensure they are legitimate.

2. **Register and Complete an Online or Paper Application:**

They will collect the same

information as the official portal.

3. **Identity Verification:** Some agencies use in-person verification at a participating location (like a post office) to confirm your identity.
4. **Pay a Service Fee:** The fee is usually higher than applying directly because of the convenience and added services (e.g., expedited processing).
5. **Receive Your Results:** The agency will send you the certificate via secure email or physical mail, often faster than the official route.

**Tip:** Only use third-party agencies if they are specifically authorized by your government; otherwise, the check may

not be accepted by the requesting organization.

## REQUIRED DOCUMENTS AND INFORMATION

---

Regardless of the method you choose, you will need to provide accurate personal information and identification. Common requirements include:

- **Proof of Identity:** Usually a combination of one primary document (passport, national ID card, or birth certificate) and one secondary document (driver's license, student card, social security card, or utility bill). Some jurisdictions require a total of 100 points of ID.
- **Current Address History:** You must list all addresses where you have lived for the past 5 to 10 years, with exact dates (month and year) to the best of your knowledge.
- **Name History:** Any legal name changes, aliases, or alternative spellings (e.g., maiden name, hyphenated last name) must be disclosed.
- **Purpose of Check:** Many applications ask for a code or reason (e.g., employment, volunteer, visa). The type of check you apply for depends on this purpose.
- **Consent and Authorization:** You must give explicit permission to the agency to search your records.
- **Fingerprints (If Applicable):** For

a name-based check, fingerprints are not always required; however, fingerprint-based checks are more accurate and sometimes mandatory for certain roles.

Make sure all documents are valid, not expired, and the names match across all forms. Any discrepancies can cause delays or rejection.

---

## FEES AND PROCESSING TIMES

---

The cost of obtaining a police check varies significantly depending on your location and the type of check. Here are some rough estimates (2025 rates):

- **Basic online police check (e.g., Australia - AFP):** Approximately AUD \$42 for a name-based check, with optional expedited fee.

- **UK DBS Basic Check:** £23 (online), £18 (paper) for basic; Standard £26; Enhanced £44.
- **US FBI Identity History Summary Check:** \$18 for the request plus \$59 for the fingerprint card processing (totaling ~\$77).
- **Canada RCMP Criminal Record Check:** Varies by province; roughly CAD \$25-\$50 for a name-based check; fingerprint-based about \$50-\$70.
- **Third-party agencies:** May add a markup of \$20-\$100+ for faster service.

Processing times can range from a few minutes (automated online checks for simple records) to four to eight weeks (for manual fingerprint-based checks or

international checks). During peak seasons (e.g., summer hiring, school starting) processing may be slower. Plan ahead and apply as early as possible.

## COMMON USES FOR POLICE CHECKS

---

Understanding the purpose helps you choose the right type. Here are the most frequent use cases:

- **Employment Screening:**

Employers check criminal history

to ensure a safe work environment, especially for roles handling money, data, or vulnerable people.

- **Volunteer Work:** Non-profits and charities require checks to protect clients and staff. Many have fee waivers for volunteers.
- **Immigration and Visa:** Countries like Canada, Australia, the US, and the UK ask for police certificates from applicants who have lived there for six months or more.
