## Lockout/Tagout (LOTO)

Lockout/tagout procedures are critical for preventing unexpected energization or release of hazardous energy during maintenance

activities. Test questions often focus on the steps of energy isolation, the roles of authorized and affected employees, and the requirements for periodic inspections of LOTO procedures.

## Personal Protective Equipment (PPE)

PPE questions typically require you to match specific hazards with appropriate protective equipment.

Understanding the hierarchy of controls and when PPE is necessary as a last line of defense is essential. Questions may also

cover employer requirements for providing PPE, training obligations, and proper maintenance.

## Electrical Safety

Electrical safety questions often address safe work practices around energized equipment, the effects of electric current on the human body, and requirements for guarding live parts. Understanding the difference between qualified and unqualified persons regarding electrical work is also commonly tested.

## Machine Guarding

Machine guarding questions focus on identifying points of operation, power transmission apparatuses, and other moving parts that require guarding. Participants should understand the different types of guards and devices, as well as when each type is appropriate.
