You can often sign up to speak during a public comment period. Even if you don't speak, observing helps you understand how decisions are made and who influences them. Over time, you'll recognize patterns

and issues that matter most to your community.

Prepare to Speak Publicly

If you do decide to address the board or council, prepare a brief, clear statement. Identify yourself, state the issue you're addressing, and make a specific request or recommendation. For example: "I am a resident of Ward 3, and I urge the council to allocate more funding for after-school programs." Practice your remarks ahead of time, and don't be nervous—elected officials are accustomed to hearing from citizens.

JOIN A POLITICAL PARTY OR ADVOCACY GROUP

Political parties offer a structured way to get involved. Attend local party meetings, which are often open to all registered members. You can help with candidate recruitment, precinct organization, and voter outreach. If partisan politics doesn't appeal to you, single-issue advocacy groups (like environmental, civil liberties, or gun safety organizations) provide another route. These groups lobby, educate, and mobilize around specific issues.

Start Small and Build Relationships

Build a Small Donor Base

Campaigns require money, but you can run a grassroots campaign by raising small amounts from many people. Use free tools like ActBlue or WinRed to collect donations online. Keep your expenses low: use volunteers for door-knocking, create your own signs, and leverage social media instead of expensive ads. Voters often appreciate a candidate who runs a humble, people-powered campaign.

USE SOCIAL MEDIA WISELY

Social media is a powerful tool for political engagement, but it can also be a minefield. Use platforms like Twitter, Instagram, and Facebook to share accurate information, promote events, and connect with elected officials. Avoid getting into heated arguments with strangers—it rarely changes minds. Instead, focus on building a small, engaged community that shares your values. Follow your representatives and comment respectfully on their posts. Online activism, when paired with offline action, amplifies your voice.
