This period was not merely a gimmick. It forced fans and critics to reconsider the very nature of celebrity identity. **The Artist Formally Known As Prince** was now a concept, a philosophy, and a revolutionary act. The Gold Experience (1995)

The Artist Formally Known As Prince released several albums during this period.
