Standard Form

The standard form of a linear equation is written as:

Ax + By = C

In this form, **A**, **B**, and **C** are integers, and **A** is typically non-negative. The standard form is useful for solving systems of linear equations, especially when using methods like elimination. It also makes it easy to find both the x-intercept and y-intercept by setting y or x to zero, respectively.

LINES IN COORDINATE GEOMETRY
