Tracking Response s and Following Up

Credit bureaus have 30 days to investigate a dispute, with a possible 15-day extension if they receive additional information. Track every response in your software. If a bureau verifies an item that you believe is inaccurate, you can send a second dispute with more evidence or request that a statement of dispute be included in the

client's file. If the furnisher fails to respond, the item must be removed. Persistence and attention to detail are key; some items require multiple rounds of dispute before they are corrected or removed.
