- **Seams and Joints:** In single-ply membranes, check seam integrity. For metal roofs,

check fastener

Photographic Documentation

A picture is worth a thousand words. The template should have designated spaces to insert and caption photographs. A best practice is to include wide-angle shots of each roof section, close-ups of any deficiencies, and images of the general context (e.g., adjacent buildings, rooftop equipment).

4. Severity and Priority Rating System

To make the report actionable, include a clear rating scale for each deficiency. Common systems use terms like:

- **Critical / Immediate:** Requires urgent attention (e.g., active leak, structural concern).
- **Major / Short-Term:** Requires repair within 3-6 months to

prevent further deterioration.

- **Minor / Long-Term:**

Observations to monitor over the next 1-2 years.

- **Good / No Action:**

Acceptable condition.

5. Maintenance Recommendations and Action

Plan

Based on the findings, the report should provide clear, prioritized recommendations. This section might include:

- **Immediate repairs** with estimated costs
- **Short-term maintenance tasks** (e.g., clearing drains, resealing a penetration)
- **Long-term planning** (e.g., expected remaining service life, replacement timeline)

Summary and Executive Overview

A one-page summary at the beginning or end of the report that highlights the most critical findings, the overall condition rating (e.g., Good, Fair, Poor), and the top three recommended actions. This is essential for busy decision-makers who need a quick grasp of the situation.
