Mattresses must be in near-perfect condition with no stains or sagging to have any value. Electronic s and Appliance S

\$3 each. Video games and consoles vary widely but can be valued using online resale markets as a reference. Toys should be clean and complete. Board games with all pieces are worth \$3 to \$10.
