INTRODUCTION: THE LONG SHADOW OF SEPARATION

A common question is: **When did segregation begin in a legal sense?** While informal segregation existed during slavery, the first formal codification is often traced to **Tennessee in 1870** with a law requiring separate railroad cars for Black and white passengers. Other states quickly followed. By the 1890s, nearly

every Southern state had enacted a comprehensive system of segregation. The U.S. Supreme Court provided constitutional legitimacy to this system in the landmark 1896 case **Plessy v. Ferguson**, which established the "separate but equal" doctrine. This ruling declared that segregated facilities were constitutional as long as they were purportedly equal, a standard that was almost never met. This moment is widely considered the official beginning of de jure (by law) segregation in the United States, even though the practice had already begun in earnest a decade earlier.

THE DEEPENING OF SEGREGATION: 1900 TO 1950

The first half of the 20th century saw the

entrenchment of segregation. It was not merely a Southern phenomenon; Northern cities also practiced de facto segregation through redlining, restrictive housing covenants, and discriminatory employment practices. However, the legal backbone of segregation was strongest in the South, where it governed every aspect of daily life.

The Impact of World War I and the Great

Migration

World War I (1914–1918) and the subsequent Great Migration of African Americans from the rural South to urban centers in the North, Midwest, and West created new tensions. While the North had fewer explicit segregation laws, it developed a system of racial separation through informal practices. The resurgence of the Ku Klux Klan in the 1920s further terrorized Black communities, reinforcing segregation through violence and intimidation. By the 1930s and 1940s, the "separate but equal" doctrine was widely recognized as a failure, providing Black Americans with inferior schools, public facilities, and economic opportunities.

Key Laws That Solidified Segregation

Some of the most notorious segregation laws included:

- **Poll taxes and literacy tests** designed to disenfranchise Black voters.
- **Laws forbidding interracial marriage** (anti-miscegenation laws).
- **School segregation laws** that created separate and unequal educational systems.
- **Public accommodation laws**

requiring separate waiting rooms, restrooms, water fountains, and seating in theaters.

These laws were supported by a culture of white supremacy and enforced by both the legal system and extralegal violence, including lynchings. The question "When did segregation begin?" is therefore best answered by noting the legal foundation laid in the late 1870s and 1880s, with the Supreme Court's 1896 Plessy decision as the definitive catalyst.

The Legal Assault: Brown v. Board of Education (1954)

The most significant early victory against segregation was the Supreme Court's unanimous decision in **Brown v. Board of Education of Topeka** on May 17,

1954. The Court ruled that "separate educational facilities are inherently unequal," overturning the Plessy v. Ferguson doctrine. This decision declared that segregation in public schools was unconstitutional. While this did not immediately end all segregation, it provided the legal foundation for future challenges. The year 1954 is often cited as the beginning of the end of legal segregation.

The Civil Rights Movement: Acts

of Courage

The Brown decision faced massive resistance, particularly from white Southern politicians who vowed "massive resistance." Yet it also energized the Civil Rights Movement. Key events that chipped away at segregation include:

1. **The Montgomery Bus Boycott (1955-1956):** Sparked by Rosa Parks' refusal to give up her seat, this boycott lasted 381 days and resulted in a Supreme Court ruling that segregated buses were unconstitutional.
2. **The Little Rock Nine (1957):** Federal troops were used to enforce school integration in Little

Rock, Arkansas, demonstrating federal commitment to ending segregation.

3. **The Sit-ins and Freedom Rides (1960-1961):** College students and activists challenged segregation in lunch counters and interstate bus stations.
4. **The March on Washington (1963):** Dr. Martin Luther King Jr. delivered his "I Have a Dream" speech, pressuring the federal government for comprehensive civil rights legislation.

Landmark

Legislation: The Civil Rights Act of 1964 and the Voting Rights Act of 1965

The definitive answer to "when did segregation end" legally is found in the passage of two monumental laws:

The Civil Rights Act of 1964 outlawed discrimination based on race, color, religion, sex, or national origin in employment, in public accommodations, and in federally funded programs. It

effectively ended de jure segregation in public places such as restaurants, hotels, theaters, and parks. Signed into law by President Lyndon B. Johnson on July 2, 1964, this act was the single most important piece of legislation since Reconstruction.

The Voting Rights Act of 1965 followed, eliminating the discriminatory voting practices (such as literacy tests and poll taxes) that had been used to disenfranchise Black voters. This act was a critical step in ensuring that the end of segregation was accompanied by political empowerment.

BEYOND THE LAW: THE REALITY OF THE END OF SEGREGATION

While the Civil Rights Act of 1964 legally ended segregation, the practical end of

segregation has been far more elusive. The phrase "de jure segregation" was erased, but "de facto segregation"—segregation that exists by fact, not by law—continues to this day. Many American schools remain racially and economically segregated due to housing patterns, income inequality, and lingering effects of redlining. Similarly, neighborhoods, workplaces, and social networks often remain divided.

The answer to "When did segregation end?" must therefore include the acknowledgement that, in a strict legal sense, it ended in the mid-1960s. However, the social and economic consequences of over 80 years of Jim Crow segregation are still very much present. Even today, discussions about school busing, affirmative action, and

housing discrimination are rooted in the unresolved legacy of segregation.

GLOBAL CONTEXT: SEGREGATION BEYOND THE UNITED STATES

It is worth noting that segregation is not solely an American story. The question "When did segregation begin and end?" can be asked in many contexts. For example, the apartheid system in South Africa began officially in 1948 (although racial segregation policies existed earlier) and ended in 1994 with the election of Nelson Mandela. In Nazi Germany, the Nuremberg Laws of 1935 enforced racial segregation against Jews, ending only with the defeat of the regime in 1945. In India, the caste system has created de facto segregation for centuries. However, the most
