- **Compaction requirements:** 90% relative compaction for most trench backfills, 95% for structural fills.

- **Testing frequency:** At least one compaction test per lift per 500 linear feet of trench.

## Concrete and Mortar

Concrete is the workhorse of public works. The Greenbook prescribes minimum cement content, water-cement ratios, aggregate gradations, and curing methods for various applications. It distinguishes between concrete used in curbs, gutters, sidewalks, and structural retaining walls. Admixtures for air entrainment, retarders, and accelerators are regulated to ensure durability in different climates.

3. **Stub outs and connections:** Must be sleeved or wrapped to prevent infiltration.

## Traffic Control and Striping

Safety during construction is paramount. The Greenbook incorporates the California MUTCD (Manual on Uniform Traffic Control Devices) for temporary traffic management. It specifies retroreflective sheeting types, pavement marking materials (paint, thermoplastic, tape), and sign post installation. Work zone traffic control plans must be submitted and maintained throughout the project duration.

Rather than relying on vague terms like "adequate," the Greenbook provides numeric thresholds. The minimum concrete cover over reinforcing steel is 2 inches for structures exposed to weather. The allowable deviation from plan grade on a concrete curb is  $\pm 1/4$  inch in 10 feet. Such precise language leaves little room for subjective interpretation during field inspections.

## Life Cycle Cost Considerations

Many specifications are written with durability and maintenance in mind. For example, the requirement for air-entrained concrete in freeze-thaw zones directly reduces future spalling. The stipulation of Type 316 stainless steel hardware in corrosive environments extends structure service life. These upfront requirements lower the total cost of ownership for public agencies.
