However, when electrical impulses are disrupted, the result is a dysrhythmia. DYSRHYTHMIA? DEFINING THE BASICS

A dysrhythmia, also known as an arrhythmia, is any abnormality in the rate, regularity, or sequence of cardiac electrical activity. The term “dysrhythmia” literally means “abnormal rhythm.” While the words dysrhythmia and arrhythmia are often used interchangeably, some clinicians prefer dysrhythmia to emphasize that the rhythm is disturbed rather than absent. Dysrhythmias can range from benign to life-threatening. Some cause no symptoms at all and are discovered incidentally during a routine examination. Others can lead to palpitations, dizziness, shortness of breath, chest pain, or syncope (fainting). In severe cases, certain dysrhythmias can cause cardiac arrest. The key to effective management lies in accurate identification, which begins with a thorough understanding of the basics.

THE CARDIAC CONDUCTION SYSTEM: THE

HIGHWAY OF THE HEART

Before diving into rhythm interpretation, it is essential to understand the heart's electrical conduction system. This system generates and transmits electrical impulses that coordinate heart muscle contraction. The major components include the following structures:

- **Sinoatrial (SA) Node:** Often called the natural pacemaker of the heart, the SA node is located in the right atrium. It typically fires at a rate of 60 to 100 times per minute, initiating each heartbeat.
- **Atrioventricular (AV) Node:**

Located between the atria and ventricles, the AV node slows down the electrical impulse, allowing the atria to contract and fill the ventricles with blood before ventricular contraction occurs.

- **Bundle of His:**

This structure conducts the impulse from the AV node into the ventricular septum.

- **Right and Left Bundle Branches:**

These pathways carry the impulse down the septum to the apex of the heart.

- **Purkinje**

Fibers: These fibers distribute the impulse

throughout the ventricular myocardium, causing coordinated ventricular contraction.

In a healthy heart, the SA node dominates as the primary pacemaker, and the impulse travels through this pathway in a predictable manner. This results in normal sinus rhythm. Dysrhythmia Basic A teaches the learner to trace this pathway on an electrocardiogram (ECG or EKG) and identify where the system has broken down.

UNDERSTANDING THE ELECTROCARDIOG RAM: THE LANGUAGE OF

DYSRHYTHMIA

The electrocardiogram is the primary tool for diagnosing dysrhythmias. It is a graphical representation of the heart's electrical activity recorded from electrodes placed on the skin. A basic understanding of ECG waveforms is fundamental to any dysrhythmia course. The key components include:

- **P Wave:**

Represents atrial depolarization (contraction). It should be small, rounded, and precede each QRS complex in normal sinus rhythm.

- **PR Interval:**

Measures the time from the beginning of the

P wave to the beginning of the QRS complex. This represents the time it takes for the impulse to travel from the SA node through the AV node. A normal PR interval is 0.12 to 0.20 seconds (3 to 5 small squares on standard ECG paper).

- **QRS Complex:**

Represents ventricular depolarization. It is typically narrow (0.06 to 0.10 seconds) in normal conduction. A wide QRS suggests that the impulse is originating from or traveling through the ventricles

abnormally.

- **ST Segment:**
Represents the period between ventricular depolarization and repolarization. Elevation or depression can indicate ischemia or injury.
- **T Wave:**
Represents ventricular repolarization. It is usually upright in leads with a positive QRS complex.
- **QT Interval:**
Measures the total time for ventricular depolarization and repolarization. Prolongation can predispose to dangerous dysrhythmias.

COMMON DYSRHYTHMIAS COVERED IN BASIC A TRAINING

Normal Sinus Rhythm

Sinus Bradycardia

In sinus bradycardia, the SA node fires at a rate slower than 60 beats per minute. The rhythm is regular, and all other features of normal sinus rhythm are present. While this can be normal in athletes or during sleep, symptomatic bradycardia may require treatment.

Sinus Tachycardia

Sinus tachycardia occurs when the SA node fires at a rate exceeding 100 beats

per minute. The rhythm is regular, and the P waves and QRS complexes are normal. Causes include exercise, fever, anxiety, pain, dehydration, and hyperthyroidism. Treatment focuses on addressing the underlying cause.

Atrial Fibrillation

Atrial fibrillation is one of the most common clinically significant dysrhythmias. It is characterized by chaotic, disorganized electrical activity in the atria. On the ECG, there are no distinct P waves; instead, there is a wavy, irregular baseline known as

fibrillatory waves. The ventricular response is typically irregularly irregular. Atrial fibrillation increases the risk of stroke and requires careful management of rate, rhythm, and anticoagulation.

Atrial Flutter

Atrial flutter is a supraventricular tachycardia characterized by a rapid, regular atrial rate (typically around 250 to 350 beats per minute). On the ECG, this appears as a “sawtooth” pattern of atrial activity, often best seen in leads II, III, and aVF. The ventricular rate depends on the degree of AV block (e.g., 2:1 or 3:1 conduction).

Premature Atrial Contractions (PACs)

Premature Ventricular Contractions (PVCs)

PACs are early beats originating from an ectopic focus in the atria. They appear as a P wave that is different in shape from the sinus P wave, followed by a QRS complex that is usually narrow. PACs are common and often benign, but frequent PACs can sometimes trigger more serious dysrhythmias.

(PVCs)

PVCs are early beats originating from an ectopic focus in the ventricles. They appear as wide, bizarre QRS complexes that are not preceded by a P wave. PVCs are common and can be benign in healthy individuals. However, frequent, multifocal, or patterned PVCs (e.g., bigeminy, trigeminy, couplets, runs of ventricular tachycardia) may require further evaluation.

Ventricular Tachycardia

Ventricular tachycardia is a life-threatening dysrhythmia characterized by three or more consecutive PVCs at a rate exceeding 100 beats per minute. The QRS complexes are wide and bizarre. Ventricular tachycardia can be monomorphic (all QRS complexes look the same) or polymorphic (QRS morphology varies). This rhythm requires immediate attention and often defibrillation if the patient is unstable.

Ventricular Fibrillation

Ventricular fibrillation is a chaotic, disorganized rhythm in which the ventricles quiver rather than contract effectively. There is no organized QRS activity, no pulse, and no cardiac output. This is a cardiac arrest rhythm requiring immediate defibrillation and advanced cardiac life support (ACLS).

Blocks (Atrioventricular Blocks)

Heart blocks represent delays or interruptions in conduction through the AV node or the bundle branches. The three degrees of AV block are:

- **First-Degree AV Block:** A prolonged PR interval (greater than 0.20 seconds) with every P wave followed by a QRS. This is usually benign but may indicate underlying conduction system disease.
- **Second-Degree**

AV Block Type I (Wenckebach/Mobitz I):

Progressive prolongation of the PR interval until a QRS complex is dropped (a P wave occurs without a following QRS). The cycle then repeats. This is often transient and may be due to increased vagal tone or medication effects.

- **Second-Degree AV Block Type II (Mobitz II):**

The PR interval is constant, but some P waves are not conducted. This is more serious than Type I and often requires pacemaker

implantation.

- **Third-Degree AV Block (Complete Heart Block):**

No conduction between the atria and ventricles. The atria and ventricles beat independently. The ventricular rate is typically slow (often less than 40 to 50 beats per minute), driven by a junctional or ventricular escape rhythm. This requires immediate pacing.
