Understanding this structure is essential for Boeing suppliers because it allows them to locate critical information quickly and ensure that their production processes align with Boeing's expectations.

Even the way materials are packaged and shipped is covered by BMS. Packaging must protect the material from contamination, corrosion, and physical damage during transit and storage. Labeling must include specific information such as the BMS number, lot number, quantity, and expiration date if applicable. Shipping documentation must accompany each shipment and include certifications of compliance. These

requirements may seem minor, but they are critical to maintaining material integrity and traceability throughout the supply chain.
