Process of Elimination Is Your Best Friend

For example, if a question asks for a derivative and two of the answer choices have opposite signs, one of them is likely the correct one if you can determine the sign by reasoning. SAMPLE MULTIPLE CHOICE QUESTION WALKTHROUGH

To illustrate the strategies discussed, let us walk through a typical multiple choice question you might encounter.

Question: If $f(x) = x^2 \cdot \sin(x)$, then $f'(x) = ?$

- A) $2x \cdot \cos(x)$
- B) $2x \cdot \sin(x) + x^2 \cdot \cos(x)$
- C) $2x \cdot \sin(x) - x^2 \cdot \cos(x)$
- D) $x^2 \cdot \cos(x)$

Analysis: This question tests the product rule. The derivative of x^2 is $2x$, and the derivative of $\sin(x)$ is $\cos(x)$. Using the product rule, $f'(x) = (2x)(\sin(x)) + (x^2)(\cos(x))$. This matches option B. Notice that option A is the result of incorrectly applying the product rule (treating it like a simple derivative). Option C has a minus sign instead of a plus sign, which would be the result of a sign error. Option D forgets the first term entirely. By understanding the common mistakes, you can quickly see why B is correct.
