Applying for Federal Tax- Exempt Status with the IRS

To obtain 501(c)(3) status in the United States, you must file IRS Form 1023 or Form 1023-EZ. The 1023-EZ

is a streamlined version available to smaller organizations with projected annual gross receipts of \$50,000 or less and assets of \$250,000 or less. The standard Form 1023 is longer and more detailed, requiring extensive information about your programs, finances, and governance. Both forms require a user fee, which varies from a few hundred dollars to over a thousand. The IRS review process can take several months, so apply as early as possible. Once approved, your tax-exempt status is retroactive to the date you filed, provided you meet all requirements. This status is the cornerstone of your fundraising strategy, as it allows donors to deduct their

contributions.

State-Level Registration and Compliance

In addition to federal registration, most states require charities to register with a state agency, typically the Attorney General's office or a division of consumer affairs. This is often called charitable solicitation registration. You must also register in any state where you plan to actively solicit donations. Many states have annual reporting

requirements, including financial disclosures. Ignoring state registration can lead to fines and even the dissolution of your charity. Check the requirements for your home state and any other states where you have a significant presence.

Understanding how to start a charity means understanding that compliance is an ongoing responsibility, not a one-time event.

Getting an Employer Identifica

tion Number (EIN)

An Employer Identification Number (EIN) is like a Social Security number for your charity. You need it to open a bank account, file taxes, and hire employees. You can apply for an EIN online through the IRS website, and the process is free and immediate. Even if you do not plan to have employees, you still need an EIN for banking and tax purposes.
