Requirements

Management in a Medical Device Project

A developer of patient monitoring systems uses the handbook's Requirements Definition Process to structure a requirements

traceability example. The handbook provides the input-output model and suggests attributes such as unique identifier, source, rationale, priority, and verification method. By following this guidance, the team reduces the number of late-stage requirement changes by 30%.

Another limitation is its natural bias toward traditional systems engineering domains (defense, aerospace). While recent editions have added examples from medical and automotive domains, practitioners in rapidly evolving fields like software-only startups may find parts less applicable. Nevertheless, the

principles of stakeholder analysis, requirement management, and risk management remain universally valuable.
