A lower initial temperature allows the fish to cook through without burning the batter, followed by a higher temperature to finish crisping it. This two-stage frying process is a hallmark of Heston Blumenthal fish and chips.

### **THE CHIPS: TWICE-COOKED PERFECTION**

The chip is often the unsung hero of fish and chips, but Blumenthal treats it with the same scientific respect as the fish. His chips are a study in texture, achieving a fluffy interior and a crunchy, almost caramelised exterior. He

## The Triple-Cook Method

1. **First Cook (Blanching):** The chips are gently simmered or blanched in water (sometimes with a touch of vinegar) until they are just tender on the outside but still

2. **Second Cook (First Fry):** The chips are then fried at a lower temperature (around 130-140°C) until they are cooked through and soft but not coloured. This step drives out moisture and creates a soft, fluffy interior. After cooling, they are often frozen, which creates ice crystals that rupture the cell walls, leading to an even fluffier texture on the final fry.
3. **Third Cook (Second Fry):** Just before serving, the frozen chips are fried at a higher temperature (around 180-190°C) until they are deep golden brown and incredibly crispy. The result is a chip that has

a thick, crunchy crust and a perfectly light and fluffy heart.

He builds his sauce from scratch, often using a base of good-quality mayonnaise, finely chopped cornichons, capers, shallots, and fresh herbs like parsley and tarragon. The acidity from the pickles and the sharpness of the herbs are balanced carefully to create a sauce that complements, rather than overwhelms, the delicate flavour of the fish. Some versions of **Heston Blumenthal fish and chips** also feature a tempura-style fried seaweed or a light dusting of seaweed powder on the fish, adding an extra layer of umami and a nod to the sea from which the fish came.

## The Vinegar and Salt
