Hydrological Investigations:

TECHNOLOGICAL TOOLS FOR EARTH SCIENCE INVESTIGATIONS

Geochemical Analysis

Predictin g Natural Hazards

One compelling example of **applications and investigations in earth science** is the prediction of volcanic eruptions. Today, similar multi-parameter monitoring is used for

The discovery of new mineral deposits often begins with regional-scale surveys. A geologist might integrate satellite imagery, airborne geophysical data, and field mapping to identify prospective zones. Follow-up investigations involve
