Write down the date, time, and name of the representative you spoke with. Note any confirmation numbers or reference IDs provided during the call. This information is invaluable if you need to follow up on complex issues such as estate transfers or lost certificate replacements.

Online Investor Centre

Postal Mail

Certain transactions, such as estate transfers and lost certificate replacements, require original documents to be sent by mail. Computershare provides specific mailing addresses for different types of requests on their official website. Ensure you use the correct address to avoid processing delays.
