to lawyers, accountants, consultants, and virtual assistants are fully deductible.

- **Insurance Premiums:** Health insurance premiums for yourself and your employees, as well as business liability insurance, property insurance, and workers' compensation.
- **Rent and Utilities:** If you lease office space, track rent, electricity, water, internet, and phone bills. If you work from home, a portion of these costs may be allocated to the home office deduction.

HOW TO BUILD YOUR OWN SMALL BUSINESS TAX DEDUCTIONS WORKSHEET
