used in the UK. The formulary covers all major therapeutic areas, from cardiovascular and respiratory medicine to psychiatry and palliative care.

## STRUCTURE AND ORGANISATION OF THE BNF 65

---

The **British National Formulary BNF 65** is organised to facilitate rapid access to information. It opens with preliminary pages containing a table of contents, list of proprietary and non-proprietary names, and general guidance on prescribing. The main body is divided into chapters by therapeutic category (e.g., cardiovascular system, central nervous system, infections). Each chapter begins with a summary of drug classes, followed by individual monographs. Each monograph includes:

- **Drug name**

(generic and selected brand names)

- **Indications** and licensed uses
- **Dosage** for adults and children (with weight-based calculations where necessary)
- **Contraindications**, cautions, and important interactions
- **Side effects** ranked by frequency
- **Pregnancy and breastfeeding** information
- **Cost** bands (A, B, C, D) to support cost-effective prescribing

Beyond monographs, the BNF 65 includes essential guidelines on emergency treatment of poisoning,

prescribing in renal and hepatic impairment, drug interactions, and prescribing in the elderly. These sections are often the first port of call for clinicians managing complex patients.

## Why BNF 65 Remains Relevant

Although subsequent editions of the BNF have been published, the **British National Formulary BNF 65** holds historical importance and is still used in some contexts. For example, medical libraries, training programmes, and regulatory bodies

sometimes refer to archived editions for teaching or medicolegal purposes. The 65th edition captures a specific moment in UK pharmacotherapy – a time when new classes of drugs like direct oral anticoagulants (DOACs) were entering mainstream practice and the emphasis on rational prescribing was intensifying.

The BNF 65 was released in print format, but its content also fed into digital platforms such as the BNF website and mobile apps (which launched later). Today, most clinicians access the BNF online or via smartphone, but the print edition remains valuable for those without constant internet access or who prefer a physical copy. The **British National Formulary BNF 65** represents one of the last editions where print was the primary medium for many users.

Nonetheless, the core

principles of the BNF – accuracy, impartiality, and usability – have remained consistent through its transition to digital. The 65th edition can be considered a milestone in that digital transition, as readers began to expect hyperlinked cross-references and searchable text.

# Using BNF 65 for Educational Purposes

Medical, pharmacy, and nursing students are often introduced to



the BNF early in their training. The **British National Formulary BNF 65** is a valuable teaching resource because it provides real-world prescribing information. Students learn to navigate the structure, interpret drug monographs, and apply the information to clinical scenarios. Many educators use case studies based on BNF 65 content to teach clinical pharmacology and therapeutics.

## THE GLOBAL PERSPECTIVE: BNF VS. OTHER FORMULARIES

While the **British National Formulary BNF 65** is tailored to the UK, it is also used internationally in countries where UK prescribing practices are followed. It differs from formularies like the *Drug Facts and Comparisons* (United States) or the *Martindale: The Complete Drug Reference* in its emphasis on UK-specific licensing, NHS prescribing guidance, and cost bands. For practitioners working in the UK, it remains the gold standard.

The BNF 65 also

influenced the development of other national formularies, including the *Australian Medicines Handbook* and the *New Zealand Formulary*, demonstrating its global impact.

## CRITICISMS AND LIMITATIONS OF BNF 65

---

No reference work is perfect. Some critics of the BNF 65 noted that it could be slow to incorporate the very latest evidence, given its six-month publication cycle. Urgent safety alerts sometimes arrived after the edition was printed. Additionally, the print format meant that users had to manually check for updates via the BNF website or supplements. However, these limitations are

inherent to any printed medical formulary.

Another limitation is that the BNF does not include unlicensed or off-label uses of drugs, which are sometimes necessary in specialised areas such as paediatrics or oncology. Clinicians must rely on additional resources for such cases.

## THE LEGACY OF THE BNF 65

---

Today, the **British National Formulary BNF 65** may be considered a historical document, but its legacy endures. It set a standard for clarity, conciseness, and clinical relevance that successive editions have upheld. It was used by thousands of clinicians to make millions of prescribing decisions. For
