3. **Being overly aggressive or confrontational with the examiner:** This creates a hostile environment that will increase your baseline stress and make the test harder.
4. **Confessing to minor, unrelated offenses:** The pre-test interview is not a confessional. Do not admit to things unless specifically asked, as this information can be used to craft more stressful control questions.
5. **Failing to sleep or eat:** A depleted body will produce erratic physiology that is difficult for even

the best examiners to interpret.

CONCLUSION: TRUTH, PREPARATION, AND CALM
