## Collection of Foreign Intelligence

## All-Source Analysis

The Agency employs thousands of analysts with deep regional and functional expertise. These analysts take raw intelligence from all sources—human sources, intercepted communications, satellite imagery, and open-source media—and synthesize it into coherent assessments. This is where the phrase "connecting the dots" becomes real.

Analysts don't just report facts; they provide context, assess probabilities,

and warn of potential threats. A key part of how **The Central Intelligence Agency Operates As** a trusted advisor is through the production of the President's Daily Brief (PDB), a carefully curated summary of the most critical intelligence of the day. This function ensures that the highest levels of government are not just informed, but are given actionable, unbiased assessments to guide policy.

## Covert Action

The critical distinction is that these actions are authorized by the President and must be reported to the congressional intelligence committees. - **Directorate of Digital**

**Innovation (DDI):** A newer but

crucial directorate, the DDI focuses on leveraging cybersecurity, digital collection, and data analytics. It ensures the Agency can operate effectively in the digital domain, tracking threats from cybercriminals and state actors.

- **Directorate of Support (DS):** This backbone directorate handles logistics, security, human resources, and financial management. Without the DS, the other directorates could not function.

3. **Judicial Oversight:** While the CIA is not a law enforcement agency, its activities are still subject to the Constitution. The Foreign Intelligence Surveillance Court (FISA Court) provides a judicial

check on intelligence activities that may involve U.S. persons.
