- Collaborating with other state and federal agencies on resource management

WHO NEEDS A LICENSE FROM THE IDAHO OUTFITTERS AND

GUIDES LICENSING BOARD?

Under Idaho law, any person or business that provides outfitting or guiding services for compensation must obtain a license from the Idaho Outfitters And Guides Licensing Board. This includes individuals and companies that offer services such as:

- Hunting and fishing guiding
- Whitewater rafting and kayaking trips
- Horseback packing and trail riding
- Backpacking and hiking expeditions
- Wildlife viewing tours
- Float trips and jet boat tours
- Ice climbing and mountaineering

The board distinguishes between two

primary license types: the outfitter license and the guide license. An outfitter is a person or business that contracts with clients to provide outfitting services, often involving multiple guides. A guide is an individual who directly accompanies and instructs clients in the field. Depending on the scope of operations, an outfitter may hold a master guide license, while individual guides must hold a valid guide license.

Exemptions from Licensing

Not everyone who leads outdoor activities in Idaho needs a license from the Idaho Outfitters And Guides

Licensing Board. Certain exemptions apply, including:

- Individuals guiding friends or family without compensation
- Employees of the state or federal government performing official duties
- Licensed fishing or hunting guides operating exclusively on private land under specific circumstances
- Educational institutions conducting supervised instructional programs

Even with exemptions, anyone providing services to the public should carefully review the regulations to avoid unintentional violations, which can result in fines or legal action.

TO BECOMING A LICENSED

OUTFITTER OR GUIDE

Licensing Examination

The Idaho Outfitters And Guides Licensing Board administers a comprehensive examination that tests knowledge of Idaho laws, safety protocols, ethics, navigation, and resource conservation. The exam is offered at various locations throughout the state and requires a passing score of at least 70 percent. Many candidates invest significant time in studying the Idaho Outfitters and Guides Act, administrative rules, and industry best practices.

Step 4: Submit an Application and Fees

Along with the completed application, candidates must submit proof of meeting all requirements, along with the required licensing fees. Fees vary based on license type and duration. As of the latest published fee schedule, guide licenses and outfitter licenses have different fee structures, and there are additional charges for background checks and exam administration.

Step 5: Obtain Liability Insurance

All licensed outfitters must carry liability insurance with minimum coverage limits as specified by the board. This protects clients and the public in the event of accidents or property damage. Proof of insurance must be provided before the license is issued.

Step 6: Receive

Your License

Once all requirements are met and the application is approved, the Idaho Outfitters And Guides Licensing Board issues a license that must be prominently displayed at the outfitter's place of business. Guides must carry their license while guiding and present it upon request to law enforcement or board representatives.

CONTINUING EDUCATION AND LICENSE RENEWAL

Licenses issued by the Idaho Outfitters And Guides Licensing Board are valid for a specific period, typically one or two years, and must be renewed before expiration. Renewal requires completing

continuing education credits approved by the board. Topics may include updates to state regulations, risk management, client safety, and emerging best practices in outdoor recreation.

Continuing education ensures that licensed outfitters and guides remain current with evolving standards and maintain their skills. Failure to renew on time may result in late fees or the need to retake the examination.
